Altman Investment Management’s Large Cap Core Value Equity composite was also recognized in 2018 with PSN’s Bull & Bear Master designation (in the Large Cap Value Universe) for its performance in up and down markets relative to the performance of the broader market; specifically, for this category a product must have an R-Squared of 0.80 or greater relative to the style benchmark for a three-year period. Moreover, products must have an upside market capture over 100 and a downside market capture less than 100 relative to the style benchmark. “We are very pleased to have been recognized for our performance relative to risk. This is a feature that our clients appreciate during times of high volatility,” said Peter Altman.
